What are you talking about? A Climate Smart Advisors Glossary

Climate Smart Advisors concept	Acronym	Definition
Climate Smart Advisor	CSA	Advisors who take part in a 2-year Community of Practice with their peers, meeting min. 4 times per year and supported by the project with a number of CoP activities, including both training and peer learning activities
Climate Smart Agricultural Knowledge and Innovation System	CS AKIS	A system of actors, stakeholders and organisations at regional, national or EU level who interact in support of mutual learning, to generate, share, and use CS related knowledge and information.
Climate Smart Coach	CSC	An advisor trained through the Train the Trainer programme in WP2 on Climate Smart Farming practices and suitable advisory methods, and with the responsibility of animating and facilitating a Community of Practice building capacity with his/her peers
Climate Smart farming	CSF	An approach that can help farmers and foresters increase productivity and income in a sustainable way. It helps to build resilience and adapt to the effects of climate change, and contributes to climate change mitigation by reducing or removing greenhouse gas emissions. Climate-smart farming practices can focus on ways to reduce emissions in livestock production, to reduce farm inputs (such as fuels, energy, pesticides, mineral fertilisers) for more resource-efficiency, or to keep carbon stored in the soil. Making farming systems more diverse can make them more resilient in the face of climate change.
Climate Farm Demo	CFD	The sister project of Climate Smart Advisors. It will build a European network of Climate Smart pilot demonstration farms.
Co-Design Innovation Experiment	CoDIE	Multi-actor practice oriented innovation experiments where Climate Smart Advisors play a central role as change and innovation agents in Climate Smart Farming multi-level transitions. Co-Design Innovation Experiments (8-10 in total) fill in innovation gaps that have been identified in Climate Smart Advisory activities in Climate Smart Farming Multi-actor Innovation Projects across the EU.
Community of Practice	CoP	A Community of Practice is a group of at least 5 Climate Smart Advisors and 1 Climate Smart Coach, meeting regularly over the course of two years to improve and share their knowledge and advisory methods and skills in support of Climate Smart Farming practices.
Dissemination, Exploitation and Communication	DEC	The Dissemination, Exploitation and Communication plan will present the overall strategy for communication within and outside the project. It will be designed as a guide for all partners to help you achieve the most out of your communication process.

Climate Smart Advisors concept	Acronym	Definition
Data Management Plan	DMP	The Data Management Plan describes how scientific research results are easily findable, accessible, interoperable, as well as useable beyond the original purpose for which they were collected
Dynamic Learning Agenda	DLA	This is a tool to systematically monitor progress on short term learning goals and keep sight of the overall Climate Smart Advisors network objective.
General Assembly	GA	These are project meetings for the entire project consortium. They will be organised every 6 months, alternating between face-to-face and online.
Management Team	MT	This is the collection of Work Package (co-)leaders of the project. They meet on a regular basis (min. bi-monthly) in order to retain overview of the progress of the project activities.
Monitoring, Evaluation and Learning	ME&L	Monitoring, Evaluation and Learning is an approach to monitor and evaluate the capacity building and learning within the Climate Smart Advisors network and to improve its functioning and impact.
Multi-actor Innovation Project	MIP	A project bringing together different types of actors (e.g., farmers, advisors, researchers, policy-makers) with complementary types of knowledge and skills with the aim to innovate together.
National Coordinators	NC	The person that supervises and connects Community of Practice related activities at the national level, also ensuring connection with the Pilot Demonstration Farm network in Climate Farm Demo, and responsible for national dissemination and communication.
Network Management Board	NMB	The Network Management Board is there to organise and structure the internal communication. The Network Management Board is responsible for i) channelling all information, requests and results from the Work Packages towards the National Coordinators, who will then transfer it to Communities of Practice or the Co-Design Innovation Experiments, ii) being a first point of contact for all actors at the national level. The Network Management Board will have quarterly meetings with all National Coordinators to facilitate this process.
Pilot Demonstration Farm	PDF	One of the demonstration farms that is part of the European network built by the Climate Farm Demo project.

Climate Smart Advisors concept	Acronym	Definition
Practice Abstracts	PA	This is a short summary which describes a key recommendation/practice that can be used by the end-users in their daily practice that is uploaded on the EU CAP Network website. (https://eu-cap-network.ec.europa.eu/index_en)
Project Handbook	PMP-QAP	Project Management Procedures and Quality Assurance Plan, also referred to as the Project Handbook. This document provides a detailed plan for managing the project's activities, outcomes and impacts, offering procedures to ensure (scientific) quality of the project results and outcomes, and a risk register.
Projects, flagship Initiatives and Policy-makers Task leader	PIP	In WP7 of the Climate Smart Advisors project, the aim is to actively link to other relevant Projects, Initiatives, Policy-makers (PiPs).
	TaL	The organisation or person in charge of and responsible for a task in a Work Package.
Thematic Leaders	TL	An outstanding European expert in one of the 12 selected adaptation and mitigation thematic areas for climate change. Thematic Leaders will organise knowledge exchange between Communities of Practice and Climate Smart Agricultural Knowledge and Innovation System actors at EU level and share new and innovative knowledge
Train the Trainer	TTT	Under WP2 of the Climate Smart Advisors project, the Climate Smart Coaches (the ones who will be leading and implementing a Community of Practice) will follow a "Train the Trainer" course. They will be trained on facilitation skills, networking and good practices, tools, advisory and teaching methods suitable for their local context.
Work Package leader	WPL	The organisation in charge of and responsible for one of the Work Packages of the project.
